

## BIOGRAMS

**GINTS APALS** obtained his PhD in history from the University of Latvia. His doctoral thesis focused on the history of 19th-century nationalism. Subsequent research interests were in various aspects of modern history and international relations. From 2013 to 2017, he was Latvia's Ambassador to Ireland and then, from 2017 to 2020, Ambassador Extraordinary to the Palestinian Authority. Since 2021, he has worked at the Museum of the Occupation of Latvia, where he heads the public history department.

**IGOR CAŞU** PhD in history. Director of the National Archives Agency of the Republic of Moldova, and lecturer at the Moldovan State University in Chisinau. In 2016, he was a Fulbright Program Fellow at Stanford University, lecturing on post-war famine at the University of Toronto, Yale, and Harvard. He is the author of, among others, 'The Benefits of Comparison: Famine in Kazakhstan in the Early 1930s in Soviet Context' in the "Journal of Genocide Research" and 'Do Starving People Rebel? Hunger Riots as Bab'y Bunty in Spring 1946 Soviet Moldavia' in "New Europe College's Yearbook".

**JAMIL HASANLI** is a senior lecturer at the Institute of Historical Research, University of London. He completed his PhD in 1984 and was a professor at Baku State University in Azerbaijan from 1993 to 2011. He was an advisor to the President of Azerbaijan in 1993 and was a member of the Azerbaijani Parliament for two terms between 2000 and 2010. In 2013, he stood as a candidate in the presidential elections, representing the united opposition. He is an honorary member of the Turkish Historical Society and a member of the American Historical Association. His books have been published in Azerbaijan, Russia, the US, the UK, and Turkey, among others. Four of his monographs have been published in the Harvard Cold War Studies Book Series.

**GRZEGORZ HRYCIUK** is a professor at the University of Wrocław. His research interests focus on nationality issues in Central and Eastern Europe in the 19th and 20th centuries, the history of Ukraine and Polish-Ukrainian relations in the 20th century, and the problem of forced migration in Eastern Europe. He is the author of, among others, the monographs 'Polacy we Lwowie Poles 1939-1944: Życie codzienne', 'Przemiany narodowościowe i ludnościowe w Galicji Wschodniej i na Wołyniu w latach 1931–1948', 'Przesiedleńcy. Wielka epopeja Polaków 1944-1946', co-author of the work 'Masowe deportacje

ludności w Związku Radzieckim' as well as co-author and editor of the atlas 'Wysiedlenia, wypędzenia, ucieczki 1939-1959. Atlas ziem Polski'.

**MARAT ILYASOV** is a Chechen scholar specializing in the Caucasus studies. His research includes issues related to authoritarianism and political radicalization in the North Caucasus, as well as conflict dynamics in the South Caucasus. He also researches the attitudes of migrants from the Caucasus living in the West. He currently holds the position of visiting professor at the Global Academy at George Washington University. Before his academic career, he worked in NGOs promoting democratic ideas in the Caucasus.

**DAVID JISHKARIANI** graduated from Tbilisi State University with a BA in History and an MA in Russian Studies. He continued his studies at the Study of Eastern Europe at the University of Warsaw. Since 2014, he has been a lecturer at the Georgian-American University, Caucasus University, and Ilia State University. His research interests include the Stalinist period in Georgia, nationalism and nationality processes in the Soviet Union, persecution and purges, and ethnic displacement. He is a research fellow at the Georgian office of the Max Weber Foundation.

**ZIYABEK KABULDINOV** is a graduate of Omsk State University. He is a professor of historical sciences. Director at the Science Committee of the Republic of Kazakhstan. Member of the Project Office of the State Commission for the Full Rehabilitation of Victims of Political Repression. Editor-in-chief and member of editorial boards of specialist journals and newsletters. Research interests: history, source studies of Kazakhstan of the 19th-20th centuries.

**MANARA KALYBEKOVA** is a graduate of Kazakhstan's Abai National Pedagogical University. Doctor of history (candidate of historical sciences). Head of the Department of International Relations of the Sh. Valikhanov Institute of History and Ethnology at the Science Committee of the Republic of Kazakhstan. Author of more than 170 scientific publications, including 5 monographs. Research interests: history of the special settlement system, history of Stalinism in Kazakhstan, history of the 1920s-1930s.

**HRANUSH KHARATYAN** historian-ethnologist, head of the research group on applied anthropology at the Institute of Archaeology and Ethnography of the National Academy of Sciences of the Republic of Armenia. Research interests: ethnic, linguistic, and cultural minorities, political violence in the USSR and Turkey, political processes of constructing ethnicity, identity, and social memory. She is

the author of several works on the issues of Soviet repression, among others *Сибирь в письменных воспоминаниях и устных рассказах репрессированных армян: от ГУЛАГа до второй родины. Выселение армян „Навечно” 1949 года. Анализ и архивные документы (к 70-летию этнической депортации армян)*.

ANDRIY  
KOHUT

doctor of History, Director of the Separate State Archive of the Security Service of Ukraine. He holds a master's degree in history from Ivan Franko Lviv National University and a PhD in history from Taras Shevchenko Kyiv National University. In early March 2022, he suspended his Fulbright Programme fellowship at Stanford University due to Russia's invasion of Ukraine. His academic and professional interests include topics related to Soviet deportations, the history of communist secret services, the politics of memory, and cultural diplomacy.

BARTŁOMIEJ  
KRZYSZTAN

political and cultural scientist, assistant professor at the Institute of Political Studies of the Polish Academy of Sciences, and independent analyst. Graduate of political science at Université Libre de Bruxelles and political science and cultural studies at the University of Wrocław. His research interests include political anthropology, cultural and political memory, postcolonialism, and national and ethnic identity. Head of the Richard Pipes Laboratory of the Institute of Political Studies of the Polish Academy of Sciences. Author of, among others, the monograph *'Pamięć, polityczność, władza. Reprezentacje pamięci zbiorowej w Gruzji, Armenii, Górskim Karabachu i Abchazji'*.

WOJCIECH  
MATERSKI

is a professor, historian and political scientist, employee of the Department of Central and Eastern Europe and Post-Soviet Studies at the Institute of Political Studies of the Polish Academy of Sciences. He specializes, inter alia, in the history of the Soviet Union and Polish-Soviet relations, the history of the Baltic republics, Georgia, and Transcaucasia, as well as the transformation of the post-Soviet region.

DMITRIY  
PANTO

holds PhD in history and is a certified curator. He has studied history and philosophy at the Sh. Valikhanov State University in Kokshetau and the Catholic University of Lublin, currently Chief Specialist of the Scientific Department of the Second World War Museum in Gdańsk. Secretary of the Polish-Kazakhstan Historical Commission. His research interests include the history of the Catholic Church in the Russian Empire and the USSR, Stalinist terror, and deportations of people.

PAVEL  
POLIAN

is a geographer, sociologist, and historian of recent history. Professor and director of the Mandelstam Centre at the University of Economics. He has lectured at universities in Austria (Innsbruck), Germany (Hanover, Freiburg im Breisgau, Constance, Berlin), Switzerland (Basel), France (Paris), Italy (Milan, Turin) and the United States (Princeton, Washington, Boston, Hanover, Stanford). He has held several grants from the Alexander von Humboldt Foundation (1991-1993, 1996, 1998). Among other publications, he is the author of *Wbrew ich woli. Historia i geografia migracji przymusowych w Związku Radzieckim*.

ASEL  
RASHIDOVA

is an independent researcher. Her research interests focus on educational and inclusive practices in museums, as well as on memory and contemporary interpretations of 20th-century history in museums in Kyrgyzstan. She has been working with the Esimde research platform (Bishkek, Kyrgyzstan) since December 2022. She is currently a student at the University of Glasgow.

YURI  
SHAPOVAL

is a professor, and doctor of historical sciences. An employee of the I.F. Kuras Institute for Political and Ethnic-National Research of the National Academy of Sciences of Ukraine in Kyiv. Member of the joint Polish-Ukrainian working group preparing the publication of the series *Poland and Ukraine in the 20th century*, member of the German-Ukrainian Commission of Historians. From 2015-2018 co-chairman of the Ukrainian-Polish Historians Forum. Author of more than 800 publications published, among others, in Austria, Argentina, the UK, Italy, Canada, Latvia, Germany, Poland, Russia, USA, France, and Czechia.

WOJCIECH  
ŚLESZYŃSKI

is a professor, director of the Sybir Memorial Museum, and lecturer at the University of Białystok. Author of numerous scientific publications. Served as Vice-Chancellor of the University of Białystok, Director of the Institute of History, and Head of the Department of Eastern Studies at the University of Białystok. Chairman of the Polish-Kazakhstan Historical Commission. His scientific interests include the history of the borderlands, Stalinist terror, the history of the eastern provinces of the Second Republic of Poland.

ANATOL  
WIALIKI

is a doctor of history (candidate of historical sciences), and assistant professor at the Institute of History of the Polish Academy of Sciences. His research interests include archives and archival science in Belarus in the 20th century, Poles as a national minority in Belarus, Belarusians in Poland in the 20th century, political repression in the 1930s in the Soviet Union, and Belarus during World War II. Author of, inter alia, four monographs, including

Dzierżyńszczyzna 1932–1937. Rejon skazany na likwidację (2022) and more than 140 articles published in Belarus, Poland, Ukraine, and Russia.

AKMAL  
YAKUBOV

is a doctor of philosophy, graduate of Samarkand State University. Senior lecturer at the Department of Historiography and Source Studies, Faculty of History, Samarkand State University. Author of more than 30 scientific papers. Research interests: historiography and source studies, diplomatic relations, Soviet politics, and history of deportations.

GRZEGORZ  
MOTYKA

professor, historian, political scientist, expert on contemporary Polish-Ukrainian history. Employee of the Institute of Political Studies of the Polish Academy of Sciences. His research interests include Polish-Ukrainian relations after 1939 and the anti-communist resistance movement in Central Europe after 1944. He is the author of several monographs on Ukrainian issues and the Polish post-war underground, including 'Ukraińska partyzantka 1942-1960', 'Na białych Polaków obława. Wojska NKWD w walce z polskim podziemiem 1944-1953', 'Wołyń '43', 'Od rzezi wołyńskiej od akcji „Wisła”” oraz 'Akcja „Wisła” '47. Komunistyczna czystka etniczna'.

ERNEST  
WYCISZKIEWICZ

PhD in political science. Since 2016 Director of the Centre for Polish-Russian Dialogue and Understanding, now Mieroszewski Centre. Graduated in international relations from the University of Łódź and the Dual Diploma Programme of the Université Marc Bloch (Strasbourg) and the University of Łódź in contemporary translation studies. Author of numerous analytical studies, expert reports and articles on the energy policy of the Russian Federation, European Union-Russia relations, foreign policy of the Russian Federation and international climate negotiations, sanctions.
